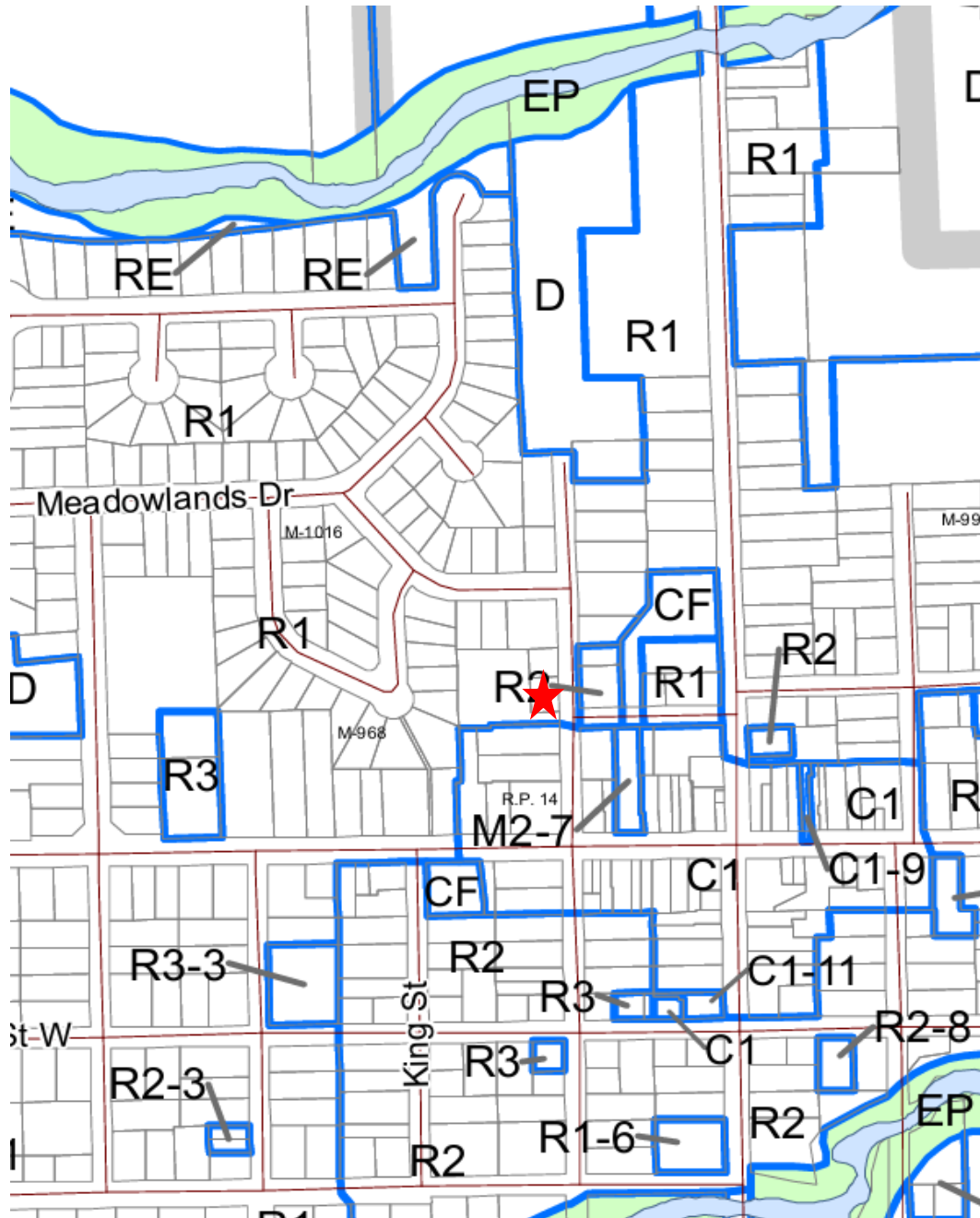


Zoning Map
